Foundation Grant to Family of Fallen Ranger



On the morning of Thursday, August 17, 2017, in the Zapotalito community, belonging to the municipality of San Pedro Tututepec, Oaxaca, Mexico, unknown persons intercepted a Ranger at Lagunas de Chacahua National Park and shot him repeatedly.

Biologist Gabriel Ramos Olivera lost his life on duty, and driving an official car of the National Commission of Natural Protected Areas.



Police cordoned off the scene of the crime, while State Agency of Investigations processed the crime scene. Among the evidence, the researchers found cartridge casings, apparently caliber .38 Special.

The Ranger Foundation in cooperation with the National Commission of Protected Areas recently presented a \$500 grant to the Ranger's family to help support the education of his daughter, Meredeth Zóe Ramos González.

President's Report

I have been working on several issues since the last Wave as follows:



I have continued to work on the issue of non-profit operation of state park units, both with department and in a meeting with Bill Craven, Chief Consultant of the Senate Natural Resources Committee. I will again ask the Board to approve a position to amend the Public Resources Code to define co-management so that the department retains responsibility for core functions.

I have spent a lot of time, with John Mott and Ann Meneguzzi on SB8 & AB 1718 (the CSP smoking ban) and testified at both the Senate and Assembly policy committee hearings, asking that the religious exception language be tightened up.

I have also followed up on the Board's approval to join the California League of Park Associations (CALPA). John Mott and I had a good meeting with CALPA President Linsey Fredenburg Humes where we discussed how the two organizations can work together. CALPA would like to have a partnership with CSPRA.

Another meeting I attended

with John Mott was with the Resource Protection Peace Officer Association (RPPOA) to discuss how CSPRA, the Ranger Foundation and RPPOA can work together. Two items seemed fruitful, namely legislation (specifically SB 8) and Ranger Foundation efforts.

I have been active with the International Ranger Federation (IRF) in regard to a proposed to complete overhaul of the IRF constitution and problems with the proposal. The proposal has now been delayed for consideration at the World Ranger Congress in Nepal. I attended the IRF Executive Committee conference-call meeting, which was interesting.

Chuck Grennell and I developed and nominated two state park lifeguards for the PRAC valor award. Chuck and I attended (by conference-call) the Valor Awards Committee where the two lifeguards and three others were approved for awards.

Finally, VP Ann Meneguzzi, Secretary Jeff Price and I attended the California Parks Training Conference in Ventura and among other things, promoted the Ranger Foundation, World Ranger Day and the World Ranger Congress in Nepal in November.

Delores Lukina 2019 Honorary Ranger

The California State Park Rangers Association (CSPRA) Board of Directors has Selected Delores Lukina as recipient of the CSPRA Honorary Ranger for 2019. The award will be presented at the CSPRA Annual Conference on October 23 at the UC Irvine Research Center in Borrego Springs.

As CSPRA President Mike Lynch has said, "The honor is in recognition of decades of work with the Anza-Borrego Foundation (ABF) and Anza-Borrego Desert State Park as a Trustee and Vice President of Acquisition. Most remarkable is that during her tenure over 22,000 acres of land was transferred to the Foundation in support and protection of Anza-Borrego Desert State Park!"

Delores' professional experience in business and acquisition was a turning point in ABF's vision regarding acquisition of large parcels of land to protect Anza-Borrego Desert State Park with new strategies that set the stage for acquiring whole projects adjacent to the park in addition to the regular individually-owned parcels (inholdings) that had been Park priorities if for years.

Other major properties that followed the consequential acquisition of Sentenac Canyon included Lucky 5, Mason valley, Tuloch Ranch and Vallecito



Ranch. Additionally, Delores worked closely with the Native American Conservancy to protect sacred lands within ABDSP. Delores is the recipient of the Medallion Award, the highest award the State can issue to a volunteer for meritorious service to State Parks and in 2001 she was named Earth Share Volunteer of the Year and in 2015, a Lifetime Achievement Award by the Anza Borrego Foundation.

I hope you can join us at the October Conference for the recognition and presentation of Delores Lukina as CSPRA's 2019 Honorary Ranger.

PRAC Medal of Valor & Award of Merit

State Park Lifeguards were honored recently at the annual California Parks Conference Valor and Honor Awards Ceremony. Scott Kwon and Joe Stoffers received the Medal of Valor for a rescue at Salt Point State Park.

Honorees are drawn from the ranks of park professionals, employed by any California, Nevada, Oregon or Washington municipal, county, state, regional or federal park agency, open space district or special park district. The nominee is not required to be a member of the Park Rangers Association of California or the California State Park Rangers Association.

Medal of Valor

The Park Rangers Association of California Medal of Valor may

be presented to any park professional who risks his or her own life to an extraordinary degree in saving or attempting to save the life of another person, or sacrifices him or herself in a heroic manner for the benefit of others.

This award recognizes the recipient's demonstration of unusual courage involving a high degree of personal risk in the

face of danger. The heroic act does not have to be related to the recipient's official duties nor occur at their official duty station.

Award of Merit

The Award of Merit may be presented by the Association to individuals whose actions are admirable or heroic, but do not rise to the level required for the Medal of Valor.

Book Review

Putting California on the Map: von Schmidt's Lines

By David Carle, (Lee Vining, CA: Phalarope Press, 2018); paperbound, 208 pages; \$14.95.

Just about every State Park employee will, at some time and place in their lives and travels, cross paths with the work of A. W. von Schmidt. One of the most successful, energetic, and innovative explorers and inventors of the nineteenth century, his name still graces maps and countryside. Like so many of his contemporaries, his renown has faded over time, but his legacy lives on in ways both tangible and subtle, but nonetheless important.

Allexey W. (A.W.) von Schmidt was born in 1821 in Courland, Russia (present day Latvia). His family emigrated to the U.S. in 1827. His father, Peter, was an engineer and surveyor, as well as an inventor. A.W. successfully followed in his father's footsteps. A.W. was also influence by John C. Fremont's exploits in the American West and California, and A.W. would even work as a surveyor on Fremont's Mariposa land grant, near Yosemite.

The von Schmidt family (father Peter and sons Allexey and Julius) were drawn to California, arriving in 1849. Like many other argonauts, they soon turned to other pursuits, includ-

ing developing hydraulic mining equipment and serving as steamboat captains on the San Francisco-Sacramento-Stockton delta. Later, A.W. returned to surveying, not only Las Mariposas but hundreds of miles of grid lines for the Public Land Survey System. He and his crew eventually walked hundreds of miles all across the state, and established not only the Mt. Diablo baseline across the Sierra Nevada but the eastern boundary of the California-Nevada border (that location is marked by CA State Historical Landmark plague #859, 14 miles north of Needles). The intellectual, physical, and professional challenges of those undertakings cannot be underestimated, and by today's standards, hardly understood. But they were considerable and remarkable, and deserving of remembrance and recognition.

He also was a visionary, who proposed using Lake Tahoe water for San Francisco's domestic purposes (a proposal that was declined, only later to be inaugurated with the drowning of Hetch Hetchy valley). And, he planned and built the first dry dock on San Francisco Bay, at Hunter's Point, and he engineered the underwater demolition of Blossom Rock in the bay, to allow for the safe passage of ships.

A.W.'s life, personal and professional, wasn't always easy. Carle chronicles these challeng-

es with objective empathy. Allexey Waldemar von Schmidt died on May 26, 1906, a month after experiencing the massive earthquake from his home in Alameda, where he and his grandchildren watched "the City," where he arrived in 1849 and that he helped to build, burn. He was 85 years old. The calamity, coinciding with his demise, eclipsed notice of his passing.

We have author, explorer, and retired State Park Ranger David Carle to thank for bringing von Schmidt's life story to our attention. A glance at the accompanying bibliography, illustrations, and maps indicate that this was a formidable undertaking in its own right. Carle concludes the book by saying, "A.W. von Schmidt's life work helped put California on the map" (p. 183). And now, David Carle's work has put von Schmidt's story in our hands, on our minds, and on our bookshelves.

- That CSPRA work with the department and legislators to seek changes in the Public Resources Code 5080.42 (4) that provide a clear definition of "co-management agreements" and add language stating that, "co-management agreements shall include the department retaining responsibility for environmental reviews, natural and cultural resource management and protection, public safety services, and overseeing of volunteers."
- CSPRA support for SB 54 and AB 1080 to "reduce waste from single-use packaging and prod-

ucts and ensure the remaining items are effectively recycled."

- Approved qualifying Ranger Foundation donor Robert Foster as a lifetime CSPRA Benefactor.
- Approved \$250 to support the 2019 Pink Bear Breast Cancer Awareness Program.
- Approved a 2019/20 CSPRA budget.

received his
B.S. in Wildlife Management from



Humboldt State University in 1971. He proudly served in the U.S. Army and was stationed in Germany, where he and Susan Ellmore met at the Oktoberfest while she was studying in Heidelberg. They raised two daughters, Allison and Molly.

Jim loved the outdoors, and spent 30 years as a California State Park Ranger, serving in numerous State Parks, including Hearst San Simeon, Big Sur, Calaveras Big Trees, Humboldt Redwoods, Angel Island, Cuyamaca Rancho, and Empire Mine State Park, where he was Chief Ranger from 1987 to 1993.

Jim will be remembered for his quick wit, easygoing and happy nature, and his intelligence and thoughtfulness. He was looked up to as a mentor by many and was a very funny and friendly man who hummed his way through life. Jim was a muchloved husband, father, son, brother, uncle, cousin, son-inlaw and brother-in-law.

Javier Morales

Javier (Xavier) Morales's died in January due to heart failure. Javier was born in 1960 to Maria and Felix Morales in San Francisco. He was the seventh out of eight siblings. His adventurous spirit stuck out to his family, and soon he was riding motorcycles in the hills of SF. He was a rocker and enjoyed his young life seeing some legendary bands like Pink Floyd, Metallica, and AC/DC.

Throughout his years, he moved up and down the golden coast of California. Eventually he settled down in McKinleyville with his wife, Kendra. They raised two daughters, Maria and Virginia, here behind the redwood curtain. He was in love with nature, and a majority of his life he worked for national and state parks. His thirst for helping others and working daring jobs started first as he worked for Calfire, then ultimately becoming a peace officer park ranger. His main career was at Patrick's Point State Park, until he had a stroke in June of 2012.

He aspired to go back to college and get his law degree. He had big plans for the future, and using a wheelchair



wasn't going to stop him.
