Major programs include:



Big Basin Wildfire

Support for Disaster Victims - Wildfire Relief

Made more than \$74,000 in emergency disaster relief grants, in conjunction with the California State Park Rangers Association. These were to eighty-four members of the California State Parks and other agency park personnel, who lost their homes and property or faced mandatory evacuations, starting in 2018 & ongoing.

Support for Latin American Rangers - COVID-19 Victims

Made 20 Covid Relief Grants of US\$500 each (\$10,000 total) to families of Latin American park rangers who died of COVID-19. These grants do not require the Covid death be work related. Because of an initial very generous donor and support from many others, especially the Association of National Park Rangers, this program is ongoing.

Support for Fallen Rangers

Provided \$5,000 (ten \$500 grants) in financial support to the families of ten fallen park rangers, for line of duty deaths (LODD) while protecting their parks in Mexico, Peru, Columbia, and Paraguay. Major partners on these grants are the California State Park Rangers Association and the Association of National Park Rangers.
